CALL TO ORDER

Chairman Cowling called the April 2022 meeting to order at 7 pm.

COMMITTEE REPORTS

FBO Committee

Vice-Chairman Dixon of the FBO Committee, recommended that the board withdraw the RFP for the FBO. The motion was unanimously passed.

Budget Committee

Ms. Kennedy discussed the preparations of the FY 2023 budget. The Committee reported that it will compare it to what was approved by the authority despite the FY 2022 budget being over \$40,000 short in City contribution.

Ms. Kennedy stated that the Authority has not been billed for IT services over the past few years. The manager will seek to clarify the amount due so that a budget amount can be determined.

OLD BUSINESS

Mr. Schrantz stated that he will be having a meeting with City Council on the construction projects going on with the Airport on the 19th of April. The Mayor has agreed to start an interview appointment procedure in appointing new members.

ENGINEERS REPORT Submitted By Steve Peterson, Talbert & Bright T-Hangar Pavement Rehabilitation – Phase 1 (Construction)

The contractor has been directed to remove a couple of sections of the asphalt that are not draining properly. Also, there are several areas where the seal coat appears to be cracking. This is continuing to be monitored but we have also asked the geotechnical engineer to look at it. Approximately \$40,000 in retainage is still being held and there is no plan to release it until everything is right.

T-Hangar Pavement Rehabilitation – Phase 2 (Construction)

Full depth repairs have been completed in the parking lot. The contractor is currently performing full depth reclamation in the T-hangar area. The schedule has the contractor milling the parking lot in the next two weeks then, weather permitting, completing all paving by the first part of May.

Maintenance Building – Design

The plans are being completed and anticipate submission to the City of Chesapeake by the end of May.

Runway and Taxiway Lighting Rehabilitation

The project is out for bid. There will be a pre-bid on April 15th and then bids will be opened on April 29th. The FAA has noted that funding for this project should be available sometime in late June or early July.

FBO Hangar Replacement Cost Estimates

Cost estimates were prepared by the architect for a couple of hangar options and sent to the airport manager. The intent is for the estimates to be distributed to the Authority members for review and comment. Mr. Peterson asked the members send their questions to Chris and he will send them to the engineer for response.

MANAGER'S REPORT

Mr. Schrantz discussed the following:

On the 26th of April, City Council will take up our request to support the bond. Mr. Schrantz will be speaking at the meeting.

The estimate from PSH, a subcontractor of Talbert & Bright, will be forwarded to the Capital Committee Chair, Mr. Cheliras, to have him evaluate it and to formulate some questions, then send it to all the members for review.

Chairman Cowling thanked everyone for all they do to further the Authority's goals along. He also asked that all members attend the City Council meeting on the 26th of April.

There being no further business, the meeting was adjourned.
