The motion was seconded and passed unanimously.

Runway and Taxiway Lighting Rehabilitation

The contractor is still planning to start work by July 17th. The last of the long lead items to ship is awaited.

Corporate Hangar Construction

The contractor has submitted the building plans to the city for permits. They are still planning to start mobilizing towards the end of June with foundation work to begin in July.

T-Hangar Taxiway Phase 3 Design

The plans have been completed and bids are due June 29^{th.} The project will go to the Virginia Aviation Board in August for funding.
