TALBERT & BRIGHT REPORT SUBMITTED BY STEVE PETERSON Obstruction Removal

We are currently waiting for final funding from the city. This project includes the removal of selected trees located in the Shillelagh Farms subdivision on the north east end of the Airport.

Storm Water Pollution Prevention Plan (SWPPP) Update

This project includes the updates to the Stormwater Pollution Prevention Plan, Spill Prevention, Control and Countermeasure Plan and the Oil Discharge Contingency Plan. The updates should take about 60 days to complete.

CLOSED MEETING

Ms. Howland made a motion that the Board of the Chesapeake Regional Airport Authority convene in a closed meeting, pursuant to the Code of Virginia as follows:

- (3) for the discussion or consideration of the acquisition or disposition of publicly held real property, where discussion in an open meeting would adversely affect the bargaining position or negotiation strategy of the Authority, and
- (5) to discuss a prospective business where no previous announcement has been made of the business interest in locating or expanding its facilities in the community.
- (8) for consultation with legal counsel retained by the Authority regarding specific legal matters requiring the provision of legal advice by such counsel, and
- (29) to discuss the award of a public contract involving the expenditure of public funds and discussion of the scope of the contract where discussion in open session would adversely affect the bargaining position or negotiating strategy of the Authority.

The motion was seconded and approved unanimously.

Following the closed meeting the chairman reconvened the open meeting.

The Chairman recognized Ms Howland for Certification of Closed Meeting:
